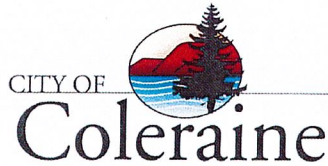

**Minutes of the SPECIAL JOINT COUNCIL MEETING
Tuesday, March 17th, 2026, 6:01 P.M.**

A special meeting of the Coleraine and Bovey City Councils was held on Tuesday, March 17th, 2026 at 6:00 p.m. at the Emergency Services Building, 501 2nd Ave., Bovey.

Bovey Mayor Yunk and Coleraine Mayor Pro-tem Sobotzak opened the meeting at 6:01pm followed by the pledge of allegiance.

A rollcall was done by Coleraine Clerk Anderson. Members present: Coleraine Mayor Pro-tem Sobotzak, Coleraine Councilpersons Giving, Wilson, and Swanson, Bovey Mayor Yunk, Bovey Councilpersons L. Meyer, N. Meyer, Robyn, and Richardson. Also present were Fire Chief Guyer, Coleraine Attorney Shaffer, Coleraine City Clerk-Treasurer Anderson, and Bovey City Clerk Werth.


The sole agenda item was determining and memorializing the annual payment split for the new Tanker for the joint Trout Lake Fire Department.

A brief discussion was had. There was also some discussion on when to schedule for review and updating of the Joint Powers Agreement. That discussion is deferred to a later date.

Motion by Coleraine Mayor Pro-tem Sobotzak, with support of Coleraine Councilperson Giving, to split the annual payment for the tanker for the Trout Lake Fire Department at a 60/40 split with Coleraine's annual 60% portion being \$32,807.75 and Bovey's annual 40% portion being \$21,871.83. Roll Call: Ayes: Mayor Pro-tem Sobotzak, Councilpersons Giving, Swanson, and Wilson. Nays: none. Motion carried.


