# CITY COUNCIL MEETING

A work session was held beginning at 3:30 p.m. and the regular meeting of the Coleraine City Council was held at 4:00 p.m., **Monday, September 8**<sup>th</sup>, 2025, in the Council Chambers of Coleraine City Hall.

# WORK SESSION 3:30 p.m.

A question was raised regarding the road maintenance agreement change that was on the agenda. It was explained that the change was simply changing the agreement with Harris Township on Jess Harry Road to do ½ of the road on both sides in a shorter length instead of the city and the township each doing one side of the road. A map of the change was included in council packets. Most of the work session was Clerk-Treasurer Anderson handing out and explaining preliminary expenditure numbers for 2026 with a reminder that this was in in conjunction with setting the preliminary levy. Her request was to have Council take home and review, ask her questions and have a longer work session on Monday September 22<sup>nd</sup> starting at 3:00pm.

## 4:00 p.m.

The regular meeting was called to order by Mayor Antonovich at 4:00 p.m. followed by the Pledge of Allegiance. A roll call was done by Clerk-Treasurer Anderson. **Members present: Councilpersons Swanson, Giving, Wilson, Sobtzak, and Mayor Antonovich.** Attorney Shaffer was also present.

Moved by Councilperson Sobtzak, supported by Giving, to approve the consent agenda which included minutes of 8.25.25, correspondence, and claims of \$66,611.96. Roll Call: Ayes: Councilpersons Sobtzak, Giving, Wilson, Swanson, and Mayor Antonovich. Nays: none. Motion carried.

Moved by Councilperson Sobtzak with support from Swanson to approve the meeting agenda with the addition of "Tanker for Trout Lake Fire Department". Ayes: All. Nays: None. Motion carried.

Resolution No. 2025-9.08—Industrial Park, Lot 6 – Motion by Councilperson Sobtzak, with support from Swanson to approve Resolution No. 2025-9.08—Industrial Park, Lot 6 releasing the right of reversion and authorizing the submission of a Quit Claim Deed for approval. Roll Call: Ayes: Councilpersons Sobtzak, Swanson, Giving, Wilson, and Mayor Antonovich. Nays: none. Motion carried.

**Quit Claim Deed**—Industrial Park, Lot 6 – Motion by Councilperson Sobtzak, supported by Swanson to approve the Quit Claim Deed for Lot 6 of the Industrial Park. Roll Call: Ayes: Councilpersons Sobtzak, Swanson, Giving, Wilson, and Mayor Antonovich. Nays: none. Motion carried.

**Resolution No. 2025-9.08—4M Fund – Motion** by Councilperson Giving, with support from Wilson, **to approve Resolution No. 2025-9.08 reauthorizing membership in the 4M Fund.** Roll Call: Ayes: Councilpersons Giving, Wilson, Swanson, Sobtzak, and Mayor Antonovich. Nays: none. Motion carried.

Mineral Rents received of \$12,986 – Motion by Councilperson Giving, supported by Swanson, to deposit the \$12,986 received from Mineral Rents into the 225 Equipment Replacement Fund. Roll Call: Ayes: Councilpersons Giving, Swanson, Wilson, Sobtzak, and Mayor Antonovich. Nays: none. Motion carried.

Add Jacob Beach as signatory to Forfeiture Savings Account – Motion by Councilperson Giving, with support from Swanson, to add Police Chief Jacob Beach to the city Forfeiture Saving Account (restricted funds). Roll Call: Ayes: Councilpersons Giving, Swanson, Wilson, Sobtzak, and Mayor Antonovich. Nays: none. Motion carried.

Jess Harry maintenance road split with Harris township – Public Works Supervisor explained the logic in the work session. The Harris Township board has already approved the revised split. Motion to approve the maintenance road split with Harris Township on a portion of the Jess Harry Road was made by Councilperson Swanson and supported by Wilson. Roll Call: Ayes: Councilpersons Swanson, Wilson, Giving, Sobtzak, and Mayor Antonovich. Nays: none. Motion carried.

Old tractor and accessories – Motion by Councilperson Sobtzak, supported by Giving, to advertise accepting bids for the old tractor and accessories and to list them separately. Roll Call: Ayes: Councilpersons Sobtzak, Giving, Swanson, Wilson, and Mayor Antonovich. Nays: none. Motion carried.

Review Snowplowing Policy – Motion by Councilperson Wilson, with support from Giving, to acknowledge the policy has been reviewed and is to remain as it is. Roll Call: Ayes: Councilperson Wilson, Giving, Swanson, Sobtzak, and Mayor Antonovich. Nays: none. Motion carried.

Tanker for Trout Lake Fire Department – It was reported that Bovey City Council rescinded their motion to pay for 50% of the Tanker and did not inform the City of Coleraine. It is unclear how much of the motion was rescinded other than the payment or if they even have the right to do it. The Joint Powers Agreement with Bovey has a clause that indicates arbitration can be requested for disputes. Motion by Councilperson Sobtzak, supported by Wilson, to direct the clerk to file for Arbitration or do whatever is necessary to set up Arbitration. Roll Call: Ayes: Councilpersons Sobtzak, Wilson, Giving, Swanson, and Mayor Antonovich. Nays: none. Motion carried.
