## SPECIAL CITY COUNCIL MEETING

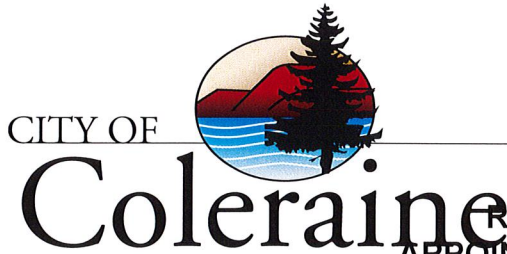

**RESOLUTION 2024-02.08 -- PNP  
APPOINTING ELECTION JUDGES FOR THE  
2024 PRESIDENTIAL PRIMARY**

**STATE OF MINNESOTA

**WHEREAS**, The State of Minnesota has called for a Presidential Primary Election on March 5<sup>th</sup>, 2024, a Primary Election on August 13<sup>th</sup>, 2024, and the county, state, and municipal governments have called a General Election on November 5<sup>th</sup>, 2024; and

**WHEREAS**, the success and vitality of a democracy is based on elections that accurately reflect the intent of the electorate, and that every vote is counted; and

**WHEREAS**, Election judges protect and promote public trust and confidence by conducting fair, accurate and open elections; and

**WHEREAS**, Election judges serve as gatekeepers of democracy to the voting process by upholding election laws with integrity, dignity and accuracy; and

**WHEREAS**, Election judges will receive the required training provided by the Itasca County Auditor's Office; and the Election Administrator (City Clerk-Treasurer) of the City of Coleraine; and

**WHEREAS**, the city is required to maintain a minimum of four election judges on sight; and

**NOW THEREFORE BE IT RESOLVED**, The Coleraine City Council hereby appoints the following to serve as election judges for the above referenced elections:
